Rules for Accepted Work:

If selected, your entry will require a jpeg of the selected work of 300 dpi hi-res images, no larger than 8x10 inches or 3500 pixels in any one direction nor smaller than 1500 pixels in any one direction, before your work is accepted in the catalog, website or exhibition. **Deadline for Catalog - Thursday, May 28, 2009**

Any accepted work that differs from the original e-mail entry will be disqualified.

All accepted work must remain in the Joyce Gordon Gallery until the close of the exhibition.

Accepted work should be suitably framed and ready for hanging with picture wire only. Works that are not properly framed will be disqualified.

Final framed images may not exceed 28" in any dimension, including frame.

Reproduction

The gallery reserves the right to reproduce accepted entries for Catalog or Publicity purposes.

Complete & sign the Joyce Gordon Gallery consignment agreement. (Please print clearly).

Accepted entries must be delivered by **Friday, June 26, 2009, 5pm**. Any work received after that time will be disqualified.

Shipping Requirements

Artists unable to deliver their photographs in person are responsible for all shipping arrangements and expenses. Round-trip shipping expenses must be prepaid or photographs will be disqualified.

Please allow two (2) weeks for shipment. Shipped items are the artist's responsibility, and all accepted work must be shipped in a reusable sturdy carton and include prepaid shipping labels to ensure its return.

The Joyce Gordon Gallery is not responsible for lost, stolen or damaged work during

shipping. All artwork to be shipped must meet shipping agents' requirements. Do **not** use packing peanuts or other loose materials in your shipment. Pack your shipment so that the packing material can be reused to send your photographs back to you. In other words, do not pack your photographs in a way that will force us to damage or discard your packing material in order to unpack your art work.

Email us the following information by **Thursday, May 28, 2009**. Even if you previously submitted this information, it's very important that you submit it again. It will be used for the "Print on Demand" Catalog and our price list and must be complete and correct.

All photographs must be framed and received by Friday, June 26, 2009. Photographs received after that date will not be exhibited. No exceptions will be made.

Using an adhesive label to clearly label the back of each framed photograph with:

Framed artwork measuring more than 28" in any direction after framing will not be exhibited. All artwork should be ready to install and properly identified with an adhesive label securely attached.

Matte the images in white, and frame them with black aluminum or black wood section frames. No glass will be accepted. All photographs must use a plastic / acrylic / Plexiglas.

For framing assistance, please contact the Joyce Gordon Gallery.

All work must be for sale. The Joyce Gordon Gallery receives a 40% commission on sales.

A signed consignment agreement must be received with your artwork or we cannot include the photograph(s) in the exhibition. No exceptions will be made. The consignment agreement will be emailed to you separately.

If your photography is shipped to us and not sold we will return it to you in the original packaging 2-3 weeks after the show closes. Remember, the photographer is responsible for arranging round-trip shipping costs.

Awards will be announced by Wednesday, May 20, 2009. Joyce Gordon will contact all award recipients personally.

Announcements / Invitations will be emailed to you on July 12th 2009. We encourage you to send the announcement to anyone you feel will be interested in the exhibition.
